2021 Summer School Student Information Agreement

1. Summer School Structure and Earning Credit

- i. Summer school students will have the option of attending in-person or remote
 - i. Past and current enrolled ALA students will be accepted for summer school
 - ii. Mesa Students verified by SCR staff will be accepted for summer school, NO EXCEPTIONS
- ii. Summer school runs Monday through Thursday, beginning Tuesday, June 1st through Thursday, June 24th. Teachers will not be available on Fridays for assistance
 - i. Please note: due to the SRPMIC Day there will be no school on Monday, June 14th
- iii. Students must register for one session: 8:00 AM to 12:00 PM or 12:30 PM to 4:30 PM or Remote session: 12:30 PM to 4:30 PM or 4:30 PM to 8:30 PM.
 - i. Students will have email or phone access to their teacher during their assigned class time, if assistance is needed outside assigned hours, staff will respond the next day
- iv. Each student will be provided a laptop

- v. Students **must submit notes** in order to access quizzes and receive credit for the completed course
 - i. Each student will be provide guided notes for Edgenuity, if available
 - ii. Teachers will go over means of submitting notes

vi. Course class assignment

- i. ALA Students may be registered in one of the classes they did not complete during the spring quarter, ALA will determine the class. If the assigned class is completed and time allows, another class may be assigned at the decision of staff and student.
- ii. Mesa Students will be assigned a class approved by Mesa Public Schools as credit recovery.

2. Attendance

- i. All students are required to attend the class for which they are scheduled.
- ii. After an accumulated 8 hours of unexcused absences, students will be dropped for lack of attendance. Attendance is taken daily for each session.
- iii. Students may also work outside of their scheduled class time.

3. Technology

- i. School issued laptops and MiFi's (if issued), **must be returned** prior to posting of grade and release of transcript.

4. Transportation
